1. Call to Order

Kevin Collins, President and CEO of Easter Seals Ontario, called the 101st Annual General Meeting (AGM) and Award Ceremony officially to order at 4:38pm, welcomed all those in attendance, both virtually and in person and read the Land Acknowledgement. The President and CEO then introduced Board Chair, Kevin Kelly, who continued with the business portion of the meeting.

2. Notice of Meeting

The Chair advised that a copy of the Notice of the Meeting had been distributed in accordance with Easter Seals Ontario's By-laws. A copy of the Notice of the Meeting, together with a Statutory Declaration of its distribution was placed before the meeting. The Chair reminded those in attendance that only members of the Corporation may vote in respect of the resolutions and other formal matters raised during this meeting and that as per the By-laws, and due to the meeting being held in person and virtually, a pause to confirm assent for each vote would be observed. For any members opposed, they should do so by raising their hand, in person or virtually and verbally declare dissent.

3. Declaration of Quorum

The Chair confirmed quorum was present and noted that 7 proxies had been received prior to the June 1, 2023 deadline and declared the meeting to be regularly called and properly constituted for the transaction of business.

4. Approval of the Minutes of June 8, 2022

A copy of the minutes of the AGM held June 8, 2022 were made available to all members of Easter Seals Ontario (ESO) prior to the meeting for review.

5. Audited Financial Statements

The Consolidated Financial Statements for the year ended December 31, 2022 and the Auditor's Report, provided by Grant Thornton, having been reviewed by the Finance & Audit Committee and approved by the Board of Directors, were published on the Easter Seals Ontario website prior to the meeting and placed before the membership.

It was noted that Grant Thornton Chartered Accountants will continue as auditors for the ensuing year, fulfilling the third year of their three-year term, ending June 2024.

6. Resolutions

The Chair handed the floor to the Vice-Chair to bring forth a request for a motion for the first resolution.

i. Extension of Term

This resolution, which was approved by the Board of Directors on December 7, 2022 and sent to all members with the Notice of Meeting is to hereby retroactively extend the term of office of Kevin Kelly from June 2022 to June 2023 in accordance with the existing By-laws.

The Vice Chair handed the floor back to the Chair to continue with the second resolution.

ii. Term of Officers

The second resolution, also included in the Notice of Meeting, was accepted by the Board on May 3, 2023. This motion is regarding the eligibility and Terms of Officers of the Corporation which would allow for the restart and refresh of a term of a Director who is appointed Chair, Vice Chair, Treasurer or Secretary, commencing on the date of appointment.

BE IT RESOLVED THAT, notwithstanding anything contained to the contrary in the Letters Patent, Articles of Amendment or the by-laws of the Corporation, the term of a Director who is appointed to hold the office of Chair, Vice Chair, Treasurer, or Secretary of the Corporation is deemed to commence on the date of such appointment and shall expire not later than the close of the third annual meeting of the Directors after such appointment.

AND BE IT FURTHER RESOLVED THAT, notwithstanding anything contained to the contrary in the Letters Patent, Articles of Amendment or the by-laws of the Corporation, a Director who is appointed to hold the office of Chair, Vice Chair, Treasurer or Secretary of the Corporation is eligible for re-appointment to such office for a second and final consecutive term expiring not later than the close of the third annual meeting of the Directors following such re-appointment; and, upon the expiry of such second and final consecutive term, such Director shall not be eligible for re-election as a Director until eleven (11) months have elapsed from such time.

The Board Chair acknowledged that one Board Director, Paolo Ciotola has requested a one-year early departure from the Board due to increased personal and professional obligations. K. Kelly thanked P. Ciotola for his expertise and contributions over the past five (5) years of service to Easter Seals Ontario.

The Chair noted that a brief biographical summary for Sean T. Martin, the one (1) candidate standing for director was provided in the meeting package. With there being no other candidates brought forth, the following motion was presented:

8. Report of the Chair of the Board of Directors

Kevin Kelly, the Chair of the Board of Directors gave his remarks that began with acknowledging and thanking the Easter Seals Ontario team who remained dedicated to families across Ontario throughout another challenging yet more normalized year, leading out of the pandemic. A financial overview with results noted included:

- The organization ended the year with a surplus of revenues over expenditures of \$878,000, an increase of \$288,000 over 2021 with \$400,000 of the surplus being set aside to support the Equipment Funding Program, \$200,000 to support our Recreation Program and \$5,000 towards Scholarships in the coming year;
- Total expenses were higher in 2022 than in 2021 by \$2.4 million. This increase was due to a combination of costs relating to the resurgence of in-person events, the re-opening of our in-person camping programs and increased equipment funding support to Easter Seals kids and families;
- Expenditures to support programs for children and families, and public education and awareness programs represented 63%; fundraising expenses were 30% and management and administrative costs 7%.

The Chair stated that it has once again been a privilege to work with so many dedicated volunteers and staff, particularly throughout the centennial year. In closing, he thanked all supporters throughout the province, for their generosity and commitment to Easter Seals Ontario and asked the President and CEO, K. Collins to provide his remarks.

9. Report of the President and CEO

Kevin Collins, President and CEO also acknowledged the ongoing challenges post-pandemic in 2022, noting that there were many successes throughout the year notably amidst post-pandemic challenges including a heightened sense of urgency for programs, services and equipment. A few notable successes that were shared included:

- The extension of equipment funding applications for the entire year with nearly \$2 million in requests approved in 2022; an increase of \$372,000 over 2021;
- The re-opening of in-person, fully accessible camps after a 2-year hiatus;
- The Ottawa centennial trip including the Ambassadors, staff and volunteers which included the
 celebration of 75 years of our Provincial Ambassador Program as well as the privilege of meeting
 several government officials, including the Prime Minister of Canada who graciously accepted ESO's
 special centennial-edition 'seals' in commemoration of our 100th anniversary;
- A continued focus on advocacy, education and awareness of children, youth and young adults with physical disabilities, accessibility and inclusion;
- A brief, high-level overview of many signature and 3rd party events and
- Thanked community partners, direct mail donors, Ontario Trillium Foundation, Rotary and service clubs, Century 21 and We Care Canada for their ongoing support.

The President and CEO concluded by thanking the Board, volunteers, sponsors, donors and staff for their support.

10. Question Period/New Business

Kevin Kelly, the Chair, opened the floor to questions and comments.
